The VITA (Volunteer Income Tax Assistance) program assists qualified taxpayers with completion of their annual tax return, to ensure that families receive every available benefit, and MyFreeTaxes.com offers online, easy to complete tax returns.

VITA volunteer tax preparers are IRS-certified and prepared to complete simple tax returns, including identifying available credits for those earning less than \$55,000 in 2018. There is absolutely *no charge* to the taxpayer for this service. UWFK is pleased to offer the VITA program through grants from Volunteer Florida and Wells Fargo. This year, UWFK will also provide taxpayers with referrals for long-term Irma recovery, when applicable.
